Smart School Bond Act 2014

- The Smart School Bond Act of 2014 was passed in 2014-15 Enacted NYS Budget and approved by the voters in a statewide referendum held during the 2014 General Election. The Smart Schools Bond Act authorized the issuance of \$2 billion of general obligation bonds to finance improved educational technology and infrastructure to improve learning and opportunity for students throughout New York State. Montauk Union Free School District was allocated \$89,032.00.
- The following plan was developed to align with our district's goals and technological needs in the coming years. Areas of focus for the District fall under the Smart Schools Bond Act categories of Classroom Learning Technologies.
